CLUB RULES, SAFETY REGULATIONS, AND WAIVER FORM

Safety is the most important issue at the club. Along with common lawful regulations set and required by the local, state, and federal law enforcements to anyone who handles a weapon, FishHawk Sporting Clays Corp. (FSC) strictly observes and reinforces the following club rules, which apply to all staff, members, and guests. We reserve the rights to stop you, perform inspections, and strictly reinforce the rules at any time.

**I. General Club Rules:**

1. Park your vehicle in an appropriate parking space and observe parking signs. Do not block the traffic.
2. Leave all weapons and ammunitions in your car until registration is complete.
3. Guests, visitors, and club member are not allowed to carry any weapons other than shotguns onto the club premises at any time. Law enforcement officers and staff on duty are exempt.
4. Observe and follow all signs, rules, and regulations on the club premise.
5. All visitors under the age of 21 must be registered together with and accompanied by an adult while on the club premises.
6. All visitors under the age of 21 are not allowed to operate golf carts or to make any purchases of ammunitions, shotguns, or weapon items sold in the club store.
7. Never consume alcohol, drugs, or influenced substances before or while shooting.
8. It is not recommended to participate in the shooting activity if you are under influence of medication.
9. Eye and ear protection are required before entering and while being in the shooting areas. No exception.
10. No animal or pet are allowed on the club premises.
11. Golf cart's maximum speed is 10 MPH. Golf carts must stay and be driven on driving paths only.
12. Any damage on golf cart, rental item, and other properties of the club shall be fully recompensed at the club's discretion.
13. Do not enter the wooded, the closed or the restricted areas.
14. Do not approach or attempt to repair any target machine. If a target machine breaks down, simply report it to the staff and move on to the next station.
15. Shooting of any wild life is simply against the laws and is strictly prohibited.
16. Courteous manners, appropriate clothing, and proper language are required. Clean your area before departing. Properly dispose used shotgun shells.

**II. Shotgun Handling Rules:**

1. Only shotguns are allowed in the club. Maximum gauge is 12. Maximum shot size is 7 ½.
2. Shotguns must have a shoulder stock and proper length.
3. Remove shotgun's case, keep it unloaded, open, and on the safety lock during transportation.
4. Shotguns must be properly held in the gun racks during transportation.
5. Even if the gun is open, unloaded, and safety locked, it must still be pointed in a safe direction at all time.
6. Never point the gun at another person as this is a serious violation of the law.
7. Keep finger off the trigger until ready to call for a target and shoot.
8. Do NOT load the gun and release the safety lock until you stand in the shooting booth with the gun pointing down the range and ready to shoot.
9. You can only load two (2) shells at each shooting. No high brass shell is allowed.
10. You are not allowed to shoot outside of the booth.
11. Only one shooter can shoot at a time at each shooting booth.
12. All shootings must be properly aimed with the gun's buttock resting from the shooter's shoulder.
13. Gun must be unloaded, open, and back on the safety lock before leaving the shooting booth.
14. Inexperienced shooters must seek assistance from trained staff and shall volunteer to be under proper guidance.
15. The club's staff reserves the right to inspect your shotgun at any time. If requested for inspection, you must unload your gun and properly hand it over with your utmost courtesy and compliance.

I hereby have read, accepted, and pledged to follow and to obey all rules and regulations set forth by FishHawk Sporting Clays Corp. I hereby certify that I am legally permitted to own and to use firearms. I also pledge to follow all other safety instructions directed by the staff at all times. I understand that the staff of FishHawk Sporting Clays Corp. reserves the rights to immediately terminate any shootings or activities at the premises without a need of explanation. Any violator shall be immediately escorted off the course, banned from the club, and prosecuted to the full extent of the law. I also understand that there are unforeseen risks involved with shooting and with physically being on the club premises; therefore, I hereby agree to hold harmless the owners, employees, staff, and agents of the FishHawk Sporting Clays Corp. for any and all damages or injuries however caused on this club's premises.
